**Blueprint Task**: Create a strategy to regularly collect via current consumer venues the gaps in community resources needed to support consumers

- Review status and Homework from April Meeting Val reviewed overview of our task. We discussed last month about how to find out current necessary resources and gaps. Discussed some of the barriers.
- Finalize strategies Suggestion Mary Beth will draft a survey to be used. Example no transportation in Missaukee County. Survey will be distributed to consumers (drop-

ins, clubhouses, peers or csms ask key consumers), peers, case managers. Mary Beth will get a draft survey out to the council and get approval.

### Blueprint Task: Recovery Enhancing Environment (REE) (presented by Dave Branding)

- Review the workgroup recommendations Dave reviewed status. A summary was provided. (see Final REE Recommendation handout).
- Review implementation plans Consider giving a description of recovery activities as a cover page. Discussed numbers small or larger group. Discussed. Val overviewed

Input on how to go about this: Michelle suggested considering a celebration. May give incentives. Keep in mind the State recommendation. Consider Learning Communities – "REE Day"- LC would host. Post a notice in lobbies ahead of time. Get word out there in many different modes. Consider mailings. May consider giving an overview of the survey to make consumers more comfortable with completion of this. Val will try to get more State input on their thinking before we move this forward.
